Initial Certification Fees

The fees below apply to the **first** attempt at a new NDT Method or Level or Sector.

Pricing is inclusive of (where applicable):

1. Initial application review and processing.
2. First attempt of (written and practical) examinations: exam papers and grading
 - a. Does **not** include fees for invigilation/facility use – contact Authorized Examination Centres for details.
 - b. Does **not** include re-examinations after failure.
3. Certification evaluations and outcomes including certificates and one wallet card.
4. Certification for 5 years, if successful.

 - a. Does **not** include fees for invigilation/facility use – contact Authorized Examination Centres for details.
 - b. Does **not** include re-examinations after failure.
3. Renewal evaluations and outcomes including certificates and one wallet card.
4. Certification renewal for 5 years, if successful.

Recertification Fees

The fees below apply to the **first** attempt at a recertification of an NDT Method or Level or Sector.

2. First attempt of practical examinations: exam papers and grading
 - a. Does **not** include fees for invigilation/facility use – contact Authorized Examination Centres (AEC) for details.
 - b. Does **not** include re-examinations after failure.
3. For Level 3, review of Structured Credit and evidence submissions **or** written (Part B and E) examination papers and grading.
4. Certification evaluations and outcomes including certificates and one wallet card.
5. Recertification for 5 years, if successful.
